- 2. The candidate should have a minimum of three years of experience in teaching/academic research/industrial research after the completion of their Ph.D. programme.
- 3. The candidate should have published at least 5 (five) research papers in recognized national or international journals.
- 4. A Research Supervisor/Co-supervisor who is a Professor, at any given point of time, cannot guide more than three (3) M.Phil. and Eight (8) Ph.D. scholars. An Associate Professor as Research Supervisor can guide up to a maximum of two (2) M.Phil. and six (6) Ph.D. scholars and an Assistant Professor as Research Supervisor can guide up to a maximum of one (1) M.Phil. and four (4) Ph.D. scholars.
- 5. As per the criteria 4, the Co-guide/Co-supervisor is abided to rule of UGC and be Guide/Co-guide of the total those many scholars only. The violation of the rule is an individual conduct, RK University is not responsible for any misconduct of the Co-guide with their parent Institution.
- 6. Notwithstanding anything mentioned above, in exceptional circumstances, the Provost (VC) may prescribe varying criteria for recognition.
